## About the Playfields Initiative

San Francisco doesn't have enough athletic fields for all 4,000 kids participating in after school sports and recreation programs in the City. Recreation and Parks simply doesn't have enough ball fields for all of the kids who want to play.

The Playfields Initiative partnership between San Francisco Recreation and Parks and the City Fields was established in 2006 to address the ongoing shortage of athletic fields in San Francisco and help Rec. & Parks equitably provide sports facilities.

The partnership renovates high-use and worn-down athletic fields with synthetic turf and/or lights, and reorganized the departments permit system to improve efficiency and equitability.

To date, the Playfields Initiative has renovated twelve athletic fields in six parks, including:

- Garfield Square
- Silver Terrace
- Franklin Square
- South Sunset Playground
- Crocker Amazon Playground
- Kimbell Playground

The \$45,000,000 program is jointly funded with \$20,000,000 in city funds and approximately \$25,000,000 in private donations.
